	Instructions for Using Product
Description of Use (s)	To aid in the cleaning of surgical instruments with small bore lumens and channels.
Preparation for Use	<ol> <li>It is important to match the diameter size of the brush you are using with the channel you are cleaning.</li> <li>The Healthmark brush-sizing chart or similar type of tool may be used to select the proper diameter brush.</li> <li>It is also critical to select a brush which is longer than the channel to ensure that the entire channel receives cleaning action.</li> <li>Fold the cut end of the Flexistem Brush to avoid sharp edges.</li> <li>It is also important to be sure the material composition of the brush bristles is suitable for the device to be cleaned. This should be in compliance with the device</li> </ol>
Diagrams (drawings, pictures):	manufacturer's IFU for the item.
Steps for Use of Product	<ol> <li>Select the proper diameter brush.</li> <li>If using from a roll, cut to a length longer than that of the channel.</li> <li>Use as a brush to clean and safely dislodge deposits. Refer to manufacture IFU when cleaning equipment.</li> <li>Dispose of brush after use.</li> </ol>
Interpretation of Results	If using synthetic fleece brush to test for cleanliness, no visible residue or staining should be seen on the white fleece of the brush.

Special Warnings and Cautions	<ul> <li>These brushes are intended for use as cleaning tools only. They are not for use in the patient care.</li> <li>The nylon bristles are stiff to provide exceptional cleaning but may cause discomfort if handled by bare hand.</li> </ul>
Disposal	<ul> <li>Dispose of after use.</li> <li>Since brushes are coming into contact with contaminated surfaces, treat as a biohazard and dispose of in compliance with facility guidelines.</li> </ul>
